While the City of Springfield waste haulers are obligated to take everything that is properly bagged, curbside recycling is a different program that uses two different recycling techniques. The Office of Public Works has put together a handout to assist residents with their recycling concerns and to explain why some items might not be picked up. FMW SPOTLIGHT ON SELECT COVENANTS

As stated previous editions of Fox Tales we will be highlighting a summary of the covenants that are more likely to impact our neighborhood on a regular basis. The covenants are designed to keep FMW one of the premier subdivisions in Springfield and to ensure we are good neighbors and stewards of our properties. If you have any questions or concerns, please do not hesitate to reach out.

This edition we will be highlighting:

- Section 5 (Mowing): All lots including vacant lots should be free of weeds and not be allowed to fall into an unsightly condition. Lawns should be maintained and mowed on a regular basis.
- Section 11 (Signs): No sign of any kind should be displayed on any lot except one sign identifying the occupants of the property, one sign advertising the property for sale or rent and signs used by contractors during the construction of any improvement on the property. The Board has generally made an exception for reasonable sized political signs ensure everyone is afforded the right of free speech.
- Section 26 (Outbuildings): No gazebo, doghouse, dog run or any other structure can be constructed without the written consent of the Architectural Control Committee (ACC).
