

MESSAGE FROM GARY NEUBAUER, PRESIDENT

I am pleased to report that things are pretty much status quo for this time of year. The fountain is in, the landscaping is being refreshed, and we are working on our lighting in the entrance area at Interlacken and Greenbriar. We have contacted the City of Springfield about damage to one of the drainage pipes that empties into the pond, and we have been placed on the list for the Department of Public Works to conduct repairs. No specific timeline has been given to us, but we will keep everyone updated as we learn more details.

As reported in past editions of Fox Tales, we want to remind everyone about guidelines for pond usage. For those not living on the pond, it can be accessed by an easement area on Lillian Drive between house numbers 2309 and 2313. The pond is surrounded by rip rap that serves a vital role in maintaining the integrity of the shoreline while enhancing the appearance of the pond. Visitors to the pond should avoid trying to walk on the rip rap and the rocks should not be disturbed to mitigate erosion and help with drainage. While the pond's primary function is to serve as a water retention area, we also want members and guests to enjoy the pond safely and responsibly. Accordingly, there are certain restrictions on the use of the pond to promote safety and to minimize liability concerns as follows:

- Swimming in the pond is prohibited.
- Using watercraft (including, but not limited to boats, canoes, rafts, kayaks and paddleboats) on the pond is prohibited.
- Throwing rip rap rocks in the pond is prohibited.
- Skating on or accessing the pond in the winter is prohibited.

We periodically like to remind everyone about some covenants that are easy to neglect. First, all lots, including vacant lots are to be kept free of weeds and not be allowed to fall into an unsightly condition. Lawns should be maintained and mowed on a regular basis. Second, vehicles (including trucks, trailers, boats, campers, or other equipment) are expected to be kept in the enclosed garage and not parked in the driveway beyond the timeframes established in the covenants.
